The report covers the Commission milestones in the year ending 2020, plans for the next year, status of ongoing projects and other activities that impact on the operation and functioning of the Commission.

During 2020, the Commission made significant progress towards fulfilling its mandate to study and keep under constant review the laws of Uganda with a view to making recommendations for their systematic improvement, development, modernization and reform. During the year under review, the Commission complied with its various accountability obligations under the Uganda Law Commission Act, Public Finance Management Act, 2015 and other <u>relevant</u> laws.

# CHAPTER: 01<u>ONE</u> INTRODUCTION

The Uganda Law Reform Commission is established under Article 248(1) of the Constitution of the Republic of Uganda and operationalized by the Uganda Law Reform Commission Act, Cap. 25 (the Act). The Commission is required under Article 248(2) of the Constitution to submit annual reports to Parliament. Section 29 and 30 (b) of the Uganda Law Reform Commission Act requires the Commission to make an annual report to the Attorney General on its proceedings who in turn shall lay the annual report before Parliament.

This report covers the period from 1st January to 31st December 2020. It presents the various milestones within the reporting period, status of rolled over projects, financial performance, planned projects and activities and also highlights challenges met by the Commission.

## 1.0 Functions of the Commission

The mandate of the Commission is to study and keep under constant review the Acts and all other laws comprising the laws of Uganda with a view to making recommendations for their systematic improvement, development, modernization and reform. In discharging its mandate, the Commission is in particular charged with:—

- (a) the elimination of anomalies in the law, the repeal of obsolete and unnecessary laws and the simplification and translation of the law;
- (b) the reflection in the laws of Uganda, the customs, values and norms of the <u>society in</u> Ugandan <u>society</u> as well as concepts and principles which are consistent with the United Nations Charter and the African Charter on Human and Peoples Rights and other international instruments to which Uganda is a party;
- (c) the development of new areas in the law <u>and-by</u> making laws responsive to the changing needs of the Ugandan society;
- (d) the adoption of new and more effective methods <u>or both</u> for the administration of the law and dispensation of justice; and

(e) the integration and unification of the laws of Uganda.

### 1.1 Powers of the Commission

In discharging its functions under Section 11 of the Act, the Commission has powers to:

- (a) receive, review and consider any proposals for the reform of the law, which may be referred to it by any person or authority;
- (b) prepare and submit to the Attorney General, for approval, programmes for the study and examination of any branch of the law with a view to making recommendations for its improvement, modernisation, and reform;
- undertake, with the approval of the Attorney General, the formulation of drafts in form of bills or other instruments for consideration by the Government and Parliament;
- (d) initiate and carry out, <u>or</u>, with approval of the Attorney General, <u>direct</u> the initiation and research necessary for the improvement and modernisation of the law;
- (e) provide, at the instance of the Government, to <u>Government</u> ministries and, departments and <u>other authorities</u> concerned, advice, information and proposals for reform or amendment of any branch of the law;
- encourage and promote public participation in the process of law making and educate and sensitise the public on law-making through seminars, publications and <u>the</u> mass media;
- (g) appoint or empanel committees in consultation with the Attorney General, from among members of the Commission, or from among persons outside the Commission, to study and make recommendations to the Commission on any aspect of the law referred to the committees by the Commission.

### 1.2 Structure of the Commission

## 1.2.1 Commissioners

The Commission comprises of the chairperson and six commissioners appointed by the President on the advice of the Attorney General. The duties of the commissioners are to formulate policies; oversee, approve and monitor strategy as well as to oversee the implementation of

operational plans, including annual work plans and budgets; providing provide guardianship of Commission values; monitoring the integrity of financial reporting; overseeing risk management and legal compliance; quality assurance; overseeing stakeholder communications; and ensuring ensure value for money. A list of the Commissioners is Annexed I.

### 1.2.2 Secretariat

The Commission is supported by a Secretariat headed by a Secretary who is also the Accounting Officer and comprised of staff who implement the plans and programs of the Commission. The Secretary and staff are appointed by the Attorney General on the recommendation of the Appointments Board of the Commission. **A list of the members of staff is Annexed II.** 

The Secretariat is structured into three departments namely; Law Referring, Law Revision and Finance and Aadministration. The departments of Law Reform department and Law Revision department are each headed by a commissioner. The Finance and Aadministration department is headed by the Undersecretary.

## a) The Law Reform Department

The department is charged with:

- (a) carrying out research and making recommendations for reform of the law;
- (b) initiating proposals for new laws to respond to changing needs of society in Uganda;
- (c) undertaking dissemination programs on proposed or enacted laws;
- (d) <u>educating, sensitizing and promoting public participation in the law</u> making process, <u>educate and sensitize the general public in the law</u> making process.

## b) The Law Revision Department

The department is responsible for:

(a) updating the laws of Uganda through the law revision process;

- (b) simplification of laws;
- (c) translation of laws; and
- (e) \_\_\_\_\_consolidation of related laws.

### c) The Finance and Administration Department

The department is responsible for providing support services to facilitate the work of the Commission. The department has responsibility for human resource management, financial management, planning, administration and reporting.

## 1.3 How the Commission does its work

The work of the Commission is derived from instructions references given by the Attorney General, Government ministry, agency or department, by way of reference or even an individual. The Commission also may on its own volition, initiate projects for law reform, depending on the needs of society, particularly as reflected in the National Development Plan. In undertaking its processes, the Commission relies on consultations with interested stakeholders.

### 1.3.1 The process of law reform

The law reform process is based on careful and thorough research. The Commission fully appreciates the importance of ensuring that its proposals for reform are grounded in practice.

The process of law reform starts with preparation of a concept paper and issues or consultation paper to guide the process. The concept paper explores the scope of the project, methodology to be adopted and identifies the key issues/gaps in the <u>existing</u> law. The issues or consultation paper provides a preliminary look at the issues surrounding the inquiry, the law in its current state and gaps if any, and sets out

provisional proposals for reform. These documents are intended to manage the stakeholder expectations about the reform objectives, scope and terms of reference.

Consultations are at the heart of any law reform process. During the law reform process, the Commission carries out consultations with relevant and interested stakeholders on the subject matter under reform. Consultations involve holding meetings, seminars, workshops and key informant interviews where necessary. Responses received are analysed and considered by the Commission in the preparation of the final report and recommendations.

## 1.3.2 The process of law revision

## (a) Making an inventory of laws

The process of law revision starts with making an inventory of all the principal laws of Uganda (Acts) and all subsidiary laws made under them.

## (b) Compilation of a checklist

This is followed by compilation of a checklist to indicate the status of each law, whether amended or repealed and if amended all the amendments to the Act should beare listed under the Act they amend. Theis checklist also process must includes amendments to schedules to Acts by subsidiary legislation.

## (c) Cleaning the statute book

This process involves incorporating amendments to where the laws-has been amended, and removing repealed, obsolete or spent laws.

## (d) Renumbering sections and subdivisions

When all the amendments have been incorporated into the Act, sections and subdivisions of Acts may require renumbering. Cross references to provisions of other laws <u>must beare</u> checked to ensure accuracy.

## (e) Arranging Acts in chapters and volumes

Acts relating to a similar subject are arranged under the same chapter. Chapters are arranged in volumes in such a manner as will enable the users to access an up-dated edition of all the laws of Uganda.

The steps described in paragraphs (a) to this paragraph apply to the revision of Acts and subsidiary legislation.

## (f) Proof-reading and editing

When the processes above are complete, the text of the laws are typeset, proof read and edited The final step is to proof read and edit the text of the laws after they have been typeset so as to ensure accuracy.

## (g) Printing

This is done <u>A</u>after thorough proofreading and editing of the entire text. <u>t</u>-The revised Acts and subsidiary legislation are sent for printing. During the printing process the revisers must proof read the dummy before the final printing of the revised laws is done.

## 1.3.3 The process of translation or simplification of laws

In the case of translation or simplification of laws, the Commission may hire a consultant to work with staff to produce a draft translated<u>or</u>/simplified version of the law. The draft is subjected to validation by the end users to ascertain correctness or validity of the draft simplified<u>or</u>/translated law.

During the validation or consultation exercise, the Commission receives responses which are analysed and considered in the preparation of the final translated or simplified versions of the law. The final version is published<u>and</u>; the Commission then disseminate<u>d</u>s the publications to relevant users.

## CHAPTER: 02TWO MILESTONES

## 2.0 Introduction

This chapter outlines the commission milestones in reform, review and revision\_of laws during the year 2020.

During the reporting period, the Commission undertook studies and made recommendations for the reform and review of selected laws, revised a number of laws, simplified and translated laws as well as publishing various reports.

## 2.1 Current projects

a) Preparation of a compendium of Electoral laws

The Commission, planned to consolidate all electoral related laws into a compendium of electoral laws. The compendium is a compilation of selected laws relating to elections and the electoral process in Uganda. While undertaking this activity, all amendments in the various parent Acts were incorporated and the repealed provisions omitted. This therefore becomes a quick point of reference with up-to-date information to the users.

During the reporting period, the Commission consolidated all the relevant laws and submitted the final Draft for printing.

b) Transcription of the Constitution into Braille for the blind and visually impaired persons

In order to promote public awareness and enhance usability of the Constitution of the Republic of Uganda and improve access to justice, the Commission planned to transcribe the Constitution into Braille.

This was informed by Article 35 of the Constitution <u>that\_gives\_which</u> <u>provides</u> persons with disabilities a right to respect and human dignity and imposes a duty on the State and society to take appropriate measures to ensure that they realize their full mental and physical potential. It is envisaged that the Braille Constitution will enable the visually impaired persons to read and understand the provisions of the Constitution so that they understand their rights and obligations.

In the reporting period, a Braille expert was procured and a draft Braille Constitution developed. Validation and publication of the same will be undertaken in 2021.

c) Translation of the Constitution into Lugwere, Aringa-ti, Madi-ti and Kupsabiny

The Commission undertook to translate the Constitution into Lugwere, Aringa-ti, Madi-ti and Kupsbiny. The translation is intended to enable Lugwere, Aringa-ti, Madi-ti and Kupsbinyspeaking communities to appreciate their rights and duties as stipulated in the Constitution. It is hoped that the translated Constitution will promote the rule of law and access to justice and will also popularise the provisions of the Constitution as envisioned by <u>under</u> Article 4(a) of the Constitution of Uganda. In the reporting period, translation into\_Lugwere and Madi was completed and awaits pre-testing and validation which <u>is</u> planned for the 4th quarter of the financial year. Translation into Aringa-ti will commence in the third quarter of the fFinancial year. Translation into Kupsabiny has not been undertaken due to limited funds and is planned for the financial year 2021/22.

### d) Development of Manual for adjudication in transitional Justice

The manual will provide operational guidelines for the use of Traditional Justice Manual (TJM) and Informal Justice Systems (IJS) to ensure uniformity in the application of traditional and informal justice systems for dispute resolution; present a framework that will provide generic principles and guidelines within which the various TJMs and IJS can operate flexibly within acceptable standards and ensure justice, peace and reconciliation; aid in the reduction of inconsistencies, unpredictability and discrimination which sometimes characterize TJMs and IJS. The intention of the manual is to address matters of: adherence to human rights values in as far as use of rites, rituals and ceremonies do not violate human rights and of individuals and communities but contribute to the restoration of peace and harmony, reconciliation and restoration of the society; accountability in the dispensation of informal justice, confidentiality, gender, record keeping of proceedings; 'best interest of the child', non-discrimination, victim rights and witness protection issues ; continuity of traditional justice mechanisms; and participation and full involvement of women and children in decision making in regard to conflict prevention and resolution and responsibility centres and their mandates in the context of Transitional Justice.

In the reporting period, stakeholder engagements were carried out to seek their views on the draft manual.

e) Preparation of guidelines for the implementation of the informal justice system (IJS)

The guidelines are intended to define the informal justice framework, create linkages between the informal and the formal justice systems (FJS),

define structures for coordination, and clarify <u>en</u>-referral and appeals processes. These are intended to introduce, direct and strengthen the incorporation of the use of IJS in the administration of Justice in Uganda. This entails the adoption clear operational guidelines to ensure uniformity of practices and complementarities of IJS with FJS. <u>The guidelines with</u> <u>further d</u>Define crimes/offenses IJS can handle, define linkages, between IJS and FJS and appeals to FJS.

In the reporting period, the Commission undertook desk research in preparation for the development of the guidelines and built consensus on the content of the guidelines.

### f) Development of the strategic plan

The Commission undertook the development of its strategic plan, to refocus itself as it moves towards executing its constitutional mandate in the next 5 years aligning to the National Development Plan III and other existing national policy frameworks. During the reporting period, a consultant was procured to undertake the activity, which was still ongoing by the end of the reporting period. A published Strategic Plan is expected before the end of June 2021.

### g) Advocacy on Co-operative Societies Act

The Government of Uganda set out to make improvements to the regulatory environment to successfully regulate the cooperative societies sector. The cooperative societies play an important role in the socioeconomic development through the creation of jobs, improvement of member income, enhancement of agricultural production and productivity, the promotion of value addition and social stability. A number of provisions

have been introduced with the enactment of the Cooperative Societies (Amendment) Act, No. 5 of 2020. Given the aforementioned background, the Commission set out to conduct a post enactment advocacy on the amended Act, to disseminate, create awareness and sensitize the users of the law as well as the general public about the provisions of the recently enacted law.

During the reporting period, the <u>C</u>eommission prepared a concept paper and held preliminary consultations with the Ministry of Trade and Cooperatives in preparation for advocacy. In addition, advocacy Materials for the Cooperatives Act were prepared.

## h) Advocacy for the Anti\_—Money Laundering Act, 2013 (as amended in 2017) (AML)

Money laundering is still a new concept for courts, prosecutors, investigators and duty bearers. There are low awareness levels among the public, law enforcement agencies, and even among reporting entities<sup>1</sup>. This has affected the implementation of the AML Act. It is therefore important that awareness about the legal framework is undertaken to enhance capacity of duty bearers in dealing with money laundering issues. It is against this background that the sector prioritized advocacy for the Anti-Money Laundering Act, 2013.

The overall objective for the post enactment advocacy for the Anti-Money Laundering Act is to combat money laundering and increase awareness about the law. Specifically, the post enactment advocacy will create

awareness of the AML Act among enforcement agencies and institutions; facilitate and enhance compliance with the Act; create awareness of the obligation's accountable persons; and train duty bearers so as to realize full effect of the law.

During the reporting period, a concept paper was prepared awaiting finalization of the draft <u>manual-guidelines</u> from the Financial Intelligence Authority before embarking on other planned activities.

i) Develop and print gender mainstreaming guidelines

As part of the overall policy framework of zero tolerance to gender violence, discrimination and inequality, JLOS supported the ULRC to develop the gender mainstreaming guidelines that seeks to support the implementation of government policies and sector strategies for enhancing gender and equity concerns. The guidelines emphasize the Commission's commitment to fight gender related inequality and violence and are designed to help the Commission, its employees and stakeholders to recognize gender disparities and to address these gender issues.

The guidelines will help to identify and implement the necessary mechanisms to respond to the gender needs, ensuring that policy and decision-making consider the interests of women and men, young and old as well as people with disabilities without any segregation. The guidelines provide a systematic and streamlined system direction through a set of actions and parameters for prevention, sanctioning as well as monitoring and evaluating progress for effective implementation of gender mainstreaming initiatives in and out of the Commission.

During the reporting period, working group meetings were held that resulted into a draft gender mainstreaming guideline, which will be validated and published by June 2021.

The Commission is a member of the Justice Law Oder Sector and receives funding from the JLOS Sector Wider Approach. # CHAPTER: 04<u>FOUR</u> EXTERNAL RELATIONS

### 5.1. Introduction

The Commission established linkages with a number of institutions and individuals who provide input and expertise in the process of law reform and law revision.

The Commission is member of the Justice Law and Order Sector (JLOS), under the sector-wide approach and therefore worked closely with the sector institutions to contribute towards achieving the sector plans.

### 5.2. Submissions on bills before Pparliament

The Commission continued to work closely with Pparliament through giving technical advice to Committees of Pparliament during consideration of bills. Particularly, the Commission made submissions on 5 bills before the Legal and Parliamentary Affairs Committee of Pparliament. These include: The Administration of Justice Bill, 2018, Law Revision Bill, 2018...

# 5.3. Technical support to government ministries and agencies on law reform.

In the reporting period, the Commission also provided advice, information and technical support to various government ministries, departments and agencies on matters relating to lawe reform. In particular, the Commission provided technical support to Uganda Registration Services Bureau (URSB) to review the Insolvency Act, 2011. Two officers were assigned to a technical working group constituted by URSB to offer technical support in the review and reform the Act. The <u>C</u>eommission also offered technical support to the ministry of Trade, industry and cooperatives in the drafting of the Consumer protection and Competition Bill, 2018.

## 5.4. Participation in Regional and international cooperation

The commission engaged and participated in East African Community Affairs (EAC) and the United Nations Commission on International Trade Law (UNCITRAL).

## 5.4.1. East African Community Affairs

During the year, the Commission continued to engage and participate in East African Community affairs in fulfilment of the aspirations under the East African Community Treaty. Particularly, the Commission chaired the taskforce meeting on harmonisation and approximation of national laws in the EAC Context held from <u>12</u> -15<sup>th</sup> February 2019 in Juba Southern Sudan. The meeting considered national reports on implementation of the sub-committee recommendation and the status of approximation of investment laws (promotion & protection) of the partner states.

The taskforce resolved that whereas there is convergence, there were certain difference in the national laws of partner states relating to investment, which require harmonisation to ensure proper functioning of the EAC Common market protocol. The Commission will continue to work with the Ministry of East African Community Affairs (MEACA), and Ministry of Justice and Constitutional Affairs to facilitate harmonisation and approximation of laws in the East African community context.

## 5.4.2. United Nations Commission on International Trade Law

The Commission also participated in the United Nations Commission on International Trade Law 53<sup>rd</sup> session. The session discussed working group reports and recommendations. The session covered, investor state dispute resolution, electronic commerce, expedited arbitration, small-medium enterprises registration, and international sales of ship.

Following the meeting, the UNCITRAL Commission concluded the international settlement Agreement resulting from mediation (the Singapore Convention) which was opened for signature by member states in August 2019. The Convention will enable enforcement of settlement Agreement resulting from mediation across boards of members. Copies of the Singapore convention and UNCITRAL model law on international settlement Agreement resulting from mediation were submitted to the Ministry of Justice and Constitutional Affairs.


